### Privacy

As a result of the operation of or your use of this Website and also in connection with the services provided by Hurley Partners Limited, we may obtain certain information about you. This Privacy Policy sets out the principles governing our processing and use of that information.

Words and phrases defined in the Terms and Conditions have the same meanings in this Privacy Policy.

We respect your privacy and will not sell or make available information about you to persons outside Hurley Partners Limited except to the limited extent specified in this Privacy Policy or with your express consent.

If you register to use restricted parts of this website we may ask you to provide certain information such as your contact details and a password. We will store this information and will use the relevant information to contact you, to inform, offer or provide you with services and otherwise in connection with our use and improvement of this Website.

We may pass information we obtain about you to third parties:

- To enable you to gain access to restricted parts of this website or any other website
- To enable us to provide or for you to receive and/or pay for a service
- To enable you to receive information you have requested to be sent to you in order to fulfill a request you may have made.

## Cookies

A cookie is a small piece of text stored on a user's computer by a web browser. Most modern browsers allow you to decide whether to accept cookies, and the time frame to keep them, but rejecting cookies may impair some of the functionality of this Website. We undertake not to abuse the personal identification aspect of cookies. We use the information to track visitor use of the Hurley Partners website and to compile statistical reports on website activity.

This website only uses strictly necessary cookies that are required for the operation of the website. The only cookies we use are:

- **utma** - *used by google analytics to track information on our website.*
- **utmz** - *again used for Google analytics purposes - scroll down to see more info on this page*

- **is\_cookie\_accepted** – *used to store the users choice to accept cookies.*

These are used for display features during the navigation of the site and they expire at the end of your session.
